

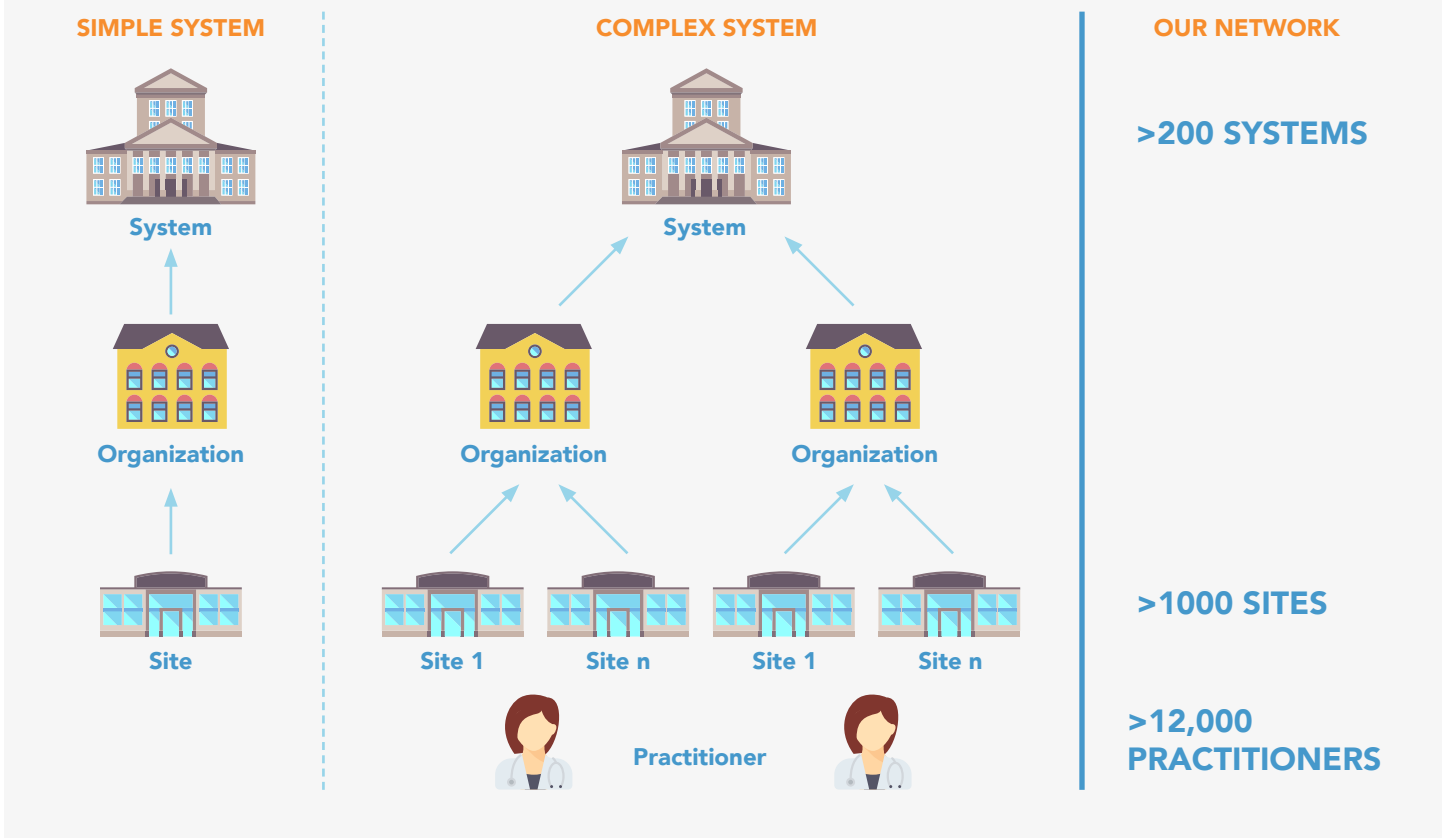

PPS PARTNER SYSTEMS

One of the core objectives of the Delivery System Reform Incentive Payment (DSRIP) program is to establish a seamless continuum of care for all New Yorkers through meaningful community collaborations and partnerships.

The OneCity Health Performing Provider System (PPS) is one of the largest in NY State, with partners across the care continuum. Given the size of our network, the relationships between partner systems, sites, and practitioners can be complex. The following schema summarizes these relationships.

The OneCity Health PPS is comprised of over 200 partner 'systems.' Depending on the complexity of the partner system organization, a system may include several organizations, sites, and practitioners. Across the 200+ systems, there are over 1,000 sites and over 12,000 practitioners.

Below is a list of OneCity Health partners at the 'system' level, in alphabetical order, that were offered a Phase II Comprehensive Schedule B as of April 1, 2017. We will update it at the start of each contracting phase.
